ARTICLES OF ORGANIZATION FOR EMERALD COAST PROPERTIES, LLC (a Florida Limited Liability Company)

The undersigned, being a member of Emerald Coast Properties, LLC, a Florida Limited Liability Company, and acting as the organizer of the Limited Liability Company, hereby adopts the following Articles of Organization for the Limited Liability Company pursuant to Chapter 608, Florida Statutes.

ARTICLE I - Name

The name of the Limited Liability Company is: Emerald Coast Properties, LLC

ARTICLE II - Duration

The period of duration for the Limited Liability Company shall be perpetual, or until dissolved in a manner provided by law, or as provided in the Regulations adopted by the members.


