ARTICLE IX - MEMBERS CANNOT BIND THE COMPANY

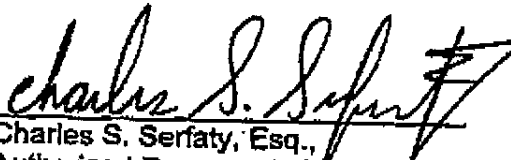
The Company is managed exclusively by the manager, and members have no authority to bind the Company.

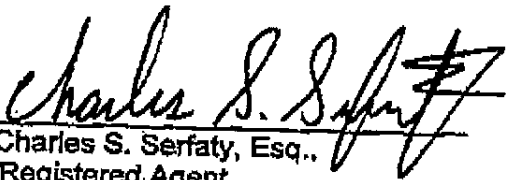
