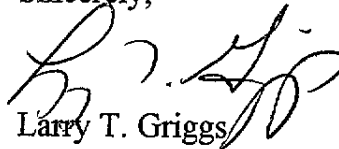

ARTICLES OF ORGANIZATION  
OF  
PRITIKA, L.L.C.

ARTICLE I

**Name**

The name of the limited liability company ("Company") is PRITIKA, L.L.C.

ARTICLE II

**Address**

The mailing address and street address of the Company's principal office is 201 Warbler Road, St. Augustine, Florida 32086. ..

ARTICLE III

**Permitted Business and Activities**

This company may engage in every phase of any and all activities or businesses permitted by the laws of the United States and the State of Florida or any other state, territory, district, or possession of the United States and all such activities or businesses as may be permitted in any foreign country. Without limitation the generality of the foregoing, the Company shall have power to:

Invest in real estate and the development of real estate and such other business activities, including the ownership of real and personal property, as are necessary and incidental to the operation of the business, or any other lawful business.

ARTICLE IV

**Terms of Existence**

The existence of this limited liability company is to begin on September 20, 2001 and to continue perpetually thereafter.

## ARTICLE VI

### **Management**

## ARTICLE VII

### **Managers' Powers**

The Managers shall have the power to fix or change salaries of the Managers as Managers, to permit contracts or other transactions between the Company and one (1) or more of its Managers or Members individually or businesses in which one (1) or more of its Managers or Members are interested, and to exercise such other powers of the Company as are not inconsistent with these Articles or with any Regulations that may be adopted by the Members.

Without limiting the generality of the foregoing, no Contract or other transaction between this Company and one (1) or more of its Managers or Members, or between this Company and any firm of which one (1) or more of its Managers or Members are members or employees, or in which they are interested, or between this Company and any company, corporation, association, or other enterprise of which one (1) or more of its members are stockholders, members, directors, officers, or employees, or in which they are interested, shall be deemed to be invalid because of the presence of such member or members at the meeting

of the Managers of this Company, which acts upon, or in reference to, such Contract or transactions, if the fact of such interest shall be disclosed or known to the Managers and the Managers shall, nevertheless, authorize, approve and ratify such Contract or transaction by a vote of a majority of the Managers. This paragraph shall not be construed to invalidate any contract or other transaction that would otherwise be valid under the common or statutory law applicable thereto.

#### ARTICLE VIII

##### **Admission of New Members**

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

#### ARTICLE IX

##### **Continuation of Business**

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

#### ARTICLE X

##### **Indemnification**

To the greatest extent not inconsistent with the laws and public policies of Florida the Company will indemnify, as a matter of right, any Member made a party to any proceeding because he or she is or was a Member, against all liability incurred by such individuals in connection with any proceeding; provided that such individual has met the standard of conduct for indemnification set forth under Florida law.

Amendments

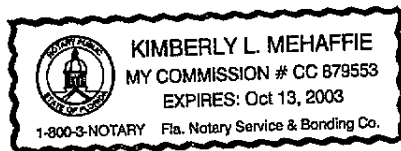

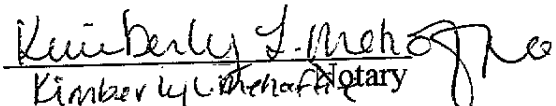
