ARTICLES OF ORGANIZATION * OF PRITIKA, L.L.C.

ARTICLE I

Name

The name of the limited liability company ("Company") is PRITIKA, L.L.C.

<u>ARTICLE II</u>

Address

The mailing address and street address of the Company's principal office is 201 Warbler Road, St. Augustine, Florida 32086.

ARTICLE III

Permitted Business and Activities

Amendments


