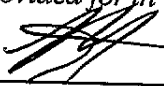

Admission of Additional Members:

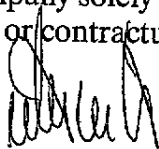

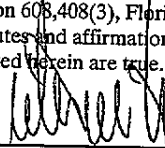
ARTICLE VII
