ARTICLES OF ORGANIZATION
OF

ACK-TEN GROUP, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608):

1. **Name.** The name of this limited liability company is **ACK-TEN GROUP, LLC** ("Company"). The Company may conduct business under that name and under any other name or names upon which the managers may select with the appeal of the member. If the company conducts business under a name other than that set forth in these Articles of Organization, then the Company shall file a fictitious name registration, as required by law, as to each such other name.
2. **Purpose.** The Company is organized to engage in any business permitted under applicable law.
3. **Duration.** The Company shall exist from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of the remaining member(s).
4. **Mailing Address and Street Address.** The Company's mailing address is 7100 Queenferry Circle, Boca Raton, FL 33496. The Company's street address is 7100 Queenferry Circle, Boca Raton, FL 33496.
5. **Registered Agent and Office.** The name of the initial registered agent of the Company is **STUART E. BLOCH, ESQ.** The street address of the initial registered agent of the Company is 980 North Federal Highway, Suite 412, Boca Raton, Florida, 33432.
6. **Additional Members.** Additional member(s) to the Company may be admitted, but only if the current Members agree to the admission of the additional member(s) and to the terms of admission.
7. **Termination of Membership.** If a Member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members may, by unanimous written agreement, continue the business of the Company.
8. **Management of the Company.** The Company shall be managed by the managers. The following persons will initially be the managers:

9. **Regulations.** The Members shall have the power to adopt, alter, amend or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

10. **Date of Existence of the Company.** The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.

11. **Limitation on Agency Authority of Members.** Pursuant to Section 608.424 of the Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no Member shall have authority to incur debt or contractual liability on behalf of The Company solely by virtue of being a member.


