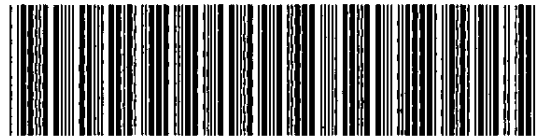

I, Anthony Sardinia, a member of S & S Construction Products, LLC, (hereinafter, the "Company"), a Florida limited liability corporation, do hereby certify that the following resolution was adopted by the members of the Company at a special meeting duly held on 7.28, 2008, and such resolutions have not been amended or rescinded and are now in full force and effect:

WHEREAS, as a result of a significant slow down in the South Florida construction industry the Company experienced a sharp decline in sales, a critical reduction in liquidity, an inability to secure additional sources of financing, loss of key personnel and demand for repayment by the Company's secured lender that could not be satisfied. All of the above has led to the decision by the Company to immediately cease business and to liquidate the Company.

NOW, THEREFORE, BE IT RESOLVED that the Company, through its Authorized Officer (Anthony Sardinia), is hereby authorized and directed to cause to be filed on behalf of the Company an Article of Dissolution for a Limited Liability Company with the Florida Department of State Division of Corporations.
