**ARTICLES OF ORGANIZATION FOR DESTINY FURNITURE, LLC**

**ARTICLE 1 – Name.** The name of the limited liability company shall be Destiny Furniture, LLC.

**ARTICLE 2 – Address of Principal Office.** The mailing address and principal office of the limited liability company shall be 2308 Longmoore Court, Orlando, Florida 32835.

**ARTICLE 3 – Registered Office and Registered Agent.** The name and the Florida street address of the initial registered agent is Edward J. Sevilla, 2308 Longmoore Court, Orlando, Florida 32835.

**ARTICLE 4 – Management.** One manager shall manage the limited liability company. Therefore, it is a manager-managed company. Initially, Edward J. Sevilla shall serve as the manager of the limited liability company. The initial manager shall receive a salary for such services and may serve in such capacity until resignation or removal for cause by a majority vote of the members.

**ARTICLE 5 – Membership.** The limited liability company shall have the following initial owners, who will hold an interest in the company as indicated below and will also act as it members:



**ARTICLE 6 – Effective Date.** The effective date of the limited liability company shall be September 20, 2001.

**ARTICLE 7 – Purposes and Powers.** The general purpose for which the limited liability company is organized shall be to engage in and transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida and all powers appurtenant thereto.
