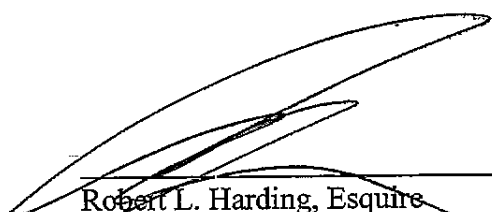

## ARTICLE VI - Miscellaneous

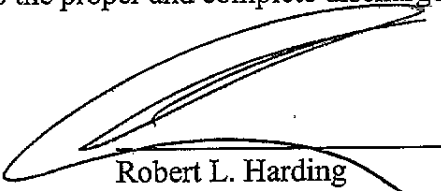
