ARTICLES OF ORGANIZATION

OF

CONTINENTAL COMMERCE, LLC.

a Florida limited liability company

- 1. The name of this limited liability company is CONTINENTAL COMMERCE, L L C (the "company").
- 2. The company is being formed for the following purposes:
