ARTICLES OF AMENDMENT TO THE
ARTICLES OF ORGANIZATION
OF
POINTE CARTESIAN, L.L.C.

Pursuant to the provisions of Section 608.411 of the Florida Statutes, the undersigned Limited Liability Company adopts the following Articles of Amendment to its Articles of Organization.

1. The date of filing the Articles of Organization was September 28, 2001.
2. Article IV is deleted in its entirety and the following substituted in lieu thereof:

"The principal place of business of Pointe Cartesian, L.L.C. shall be 2175 West 18th Street, Jacksonville, Florida 32209 and the mailing address shall be P.O. Box 551260, Jacksonville, Florida 32255 and such other place as the Member from time to time may determine.

The registered agent of Pointe Cartesian, L.L.C. shall be Michael N. Schneider whose address is 5150 Belfort Road, Building 100, Jacksonville, Florida 32256."

2. Article V is deleted in its entirety and the following substituted in lieu thereof:

"Pointe Cartesian, L.L.C. will be managed by its Members."

3. In all other respects, except as specifically changed and modified in these Articles of Amendment to the Articles of Organization, all of the provisions contained in the Articles of Organization of Pointe Cartesian, L.L.C. shall be and remain the same.
