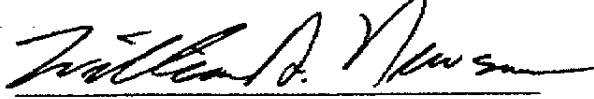

**ARTICLES OF ORGANIZATION OF
WILLIAM A. NEWSOM, M.D., P. L.**

1. Name. The name of the limited liability company (hereinafter "company") is: WILLIAM A. NEWSOM, M.D., P.L.
2. Existence. The company shall have perpetual existence. The company shall commence existence on September 28, 2001.
3. Purpose. The company is organized for the sole purpose of rendering professional medical services; provided however, the company may also invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and may own real or personal property necessary for the rendering of such professional services.
4. Location. The street address of the principal office of the company is 2521 NW 41st Street, Gainesville, FL 32606. The mailing address of the company is 2521 NW 41st Street, Gainesville, FL 32606.
5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the company is 2521 NW 41st Street, Gainesville, FL 32606 and the name of its initial registered agent at such address is William A. Newsom, M.D.
6. Additional Members. The members may admit such additional members on such terms and conditions as they may unanimously agree.
7. Continuation. A majority of the remaining members of the company shall have the right to continue the company in existence on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the company.
8. Management. The company shall be managed by one or more managers as set forth in the Membership Agreement. The initial manager shall serve until the first meeting of the members or until his successors are elected and qualify. The initial manager is William A.
