## **ARTICLES OF ORGANIZATION**

**OF**

**DWR CONSTRUCTION, LLC**

### **ARTICLE I**

#### **NAME**

The name of this limited liability company (the "Company") shall be **DWR CONSTRUCTION, LLC** and its mailing address is 843 Greens Ave., Winter Park, FL 32789, and its principal place of business is 843 Greens Ave., Winter Park, FL 32789.

### **ARTICLE II**

#### **COMMENCEMENT OF EXISTENCE**

This Company shall commence existence on the date these articles of organization are filed with the Florida Department of State and shall have perpetual existence unless sooner dissolved in accordance with the Regulations of the Company or according to law.

### **ARTICLE III**

#### **GENERAL PURPOSE; GENERAL POWERS**

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

### **ARTICLE IV**

#### **INITIAL REGISTERED OFFICE AND AGENT**

or both, from time to time without amendment of these articles of organization.

## ARTICLE V

### MANAGEMENT

The Company will be managed by the Manager as set forth in the Regulations adopted by the Company. The name and street address of the initial Manager is DAVID W. RICKETSON, 843 Greens Ave., Winter Park, FL 32789, who shall serve until either removed by the Members or resignation as provided in the Regulations. The Manager has sole authority to manage the Company and is authorized to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business. Except as authorized by the Manager, no Member is an agent of the Company or has the authority to make any contracts, enter into any transactions, or make any commitments on behalf of the Company.

## ARTICLE VI

### REGULATIONS

The power to adopt, alter, amend or repeal the regulations of the Company shall be vested in the Manager.

## ARTICLE VII

### ADMISSION OF NEW MEMBERS

Additional Members may be admitted from time to time on such terms and conditions as determined by the Manager. No current Member has any preemptive rights.

## ARTICLE VIII

### DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION, DISSOLUTION OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Manager may continue the business of the Company without a vote of the Members so long as there is at least one remaining Member of the Company.

**AMENDMENT**


The right to amend or repeal any provisions contained in these articles of organization, or any amendment hereto, is conferred upon the Manager.
