The undersigned, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Amendment.

- 1. The name of this limited liability company is Advenir@Kings, LLC, a Florida limited liability company (the "Company"), whose principal office address is 17501 Biscayne Blvd, Suite 300, Aventura, FL 33160.
