

ARTICLES OF ORGANIZATION  
OF  
FORT MYERS SURFACE PREP, L.L.C.  
(A FLORIDA LIMITED LIABILITY COMPANY)

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I  
NAME

The name of the limited liability company shall be FORT MYERS SURFACE PREP, L.L.C., and its principal place of business shall be in the City of Cape Coral, County of Lee, State of Florida, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.




