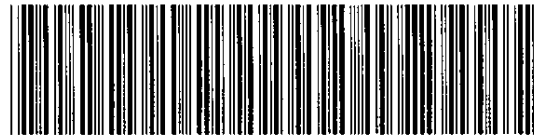

FIRST: The Articles of Organization were filed on October 3, 2001 and assigned document number L01000016917; the Articles of Organization were amended on May 16, 2007.


