The undersigned being the only members ("Members"), for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - Name

The name of the Limited Liability Company is GuestClick, L.L.C. ("Company").

ARTICLE II - Address

The mailing address and street address of the principal office of the Company shall be 5811 Pelican Bay Boulevard, Suite 206-A, Naples, Florida 34108.

ARTICLE III - Duration

The Company shall commence its existence on the date these Articles of Organization are filed with the Florida Department of State. The period of duration of the Company shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV - Purpose

The Company is formed for the object and purpose of, and the nature of the business to be conducted and promoted by the Company is, engaging in any lawful act or activity for which limited liability companies may be organized under the laws of the State of Florida.

ARTICLE V - Management

ARTICLE VI - Admission of Additional Members

One or more additional members of the Company may be admitted to the Company with the consent of all of the Members. Prior to the admission of any such additional member of the Company, the Members shall cause these Articles of Organization to be amended to make such amendments as the Members shall determine appropriate to reflect the fact that the Company shall have more than three members.

ARTICLE VII - Dissolution

The Company shall be dissolved and its affairs shall be wound up upon the first to occur of the following: (a) the written consent of all of the Members or (b) the resignation of all of the Members or the occurrence of any other event which terminates the continued membership of all of the Members in the Company.

ARTICLE VIII - Registered Office and Agent

ARTICLE IX - Capital Contribution

The Members have contributed \$1,200 in cash, and no property, to the Company.

ARTICLE X - Additional Capital Contributions

The Members may, but are not required to, make any additional capital contribution to the Company.

ARTICLE XI - Indemnification

The Company may indemnify any managing member, employee or agent of the Company to the full extent permitted by law.


