## ARTICLES OF ORGANIZATION OF TAMPA BAY RADIOLOGY, PL

#### ARTICLE I - Name

The name of the Professional Limited Liability Company is TAMPA BAY RADIOLOGY, PL (the "Company").

## ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 7171 N. Dale Mabry Highway, Tampa 33614.

#### **ARTICLE III - Purpose**

The general purpose for which the Company is organized is to engage in every aspect of the practice of medicine. The undersigned, having been named as Registered Agent and to accept service of process for the above stated limited liability company at the place designated in these Articles of Organization, the undersigned hereby accepts the appointment as registered agent and agrees to act in this capacity. The undersigned further agrees to comply with the provisions of all statutes relating to the proper and complete performance of its duties, and is familiar with and accepts the obligations of its position as registered agent as provided for in Florida Statutes Chapter 608.
