**ARTICLES OF ORGANIZATION  
OF  
TAMPA BAY RADIOLOGY CONSULTANTS, PL**

**ARTICLE I - Name**

The name of the Professional Limited Liability Company is TAMPA BAY RADIOLOGY CONSULTANTS, PL (the "Company").

**ARTICLE II - Address**

The mailing address and street address of the principal office of the Company is 7171 N. Dale Mabry Highway, Tampa 33614.

**ARTICLE III - Purpose**

The general purpose for which the Company is organized is to engage in every aspect of the practice of medicine. 
