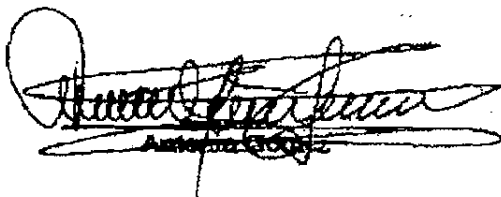

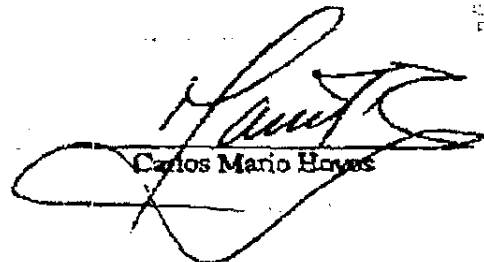
We are dissolving this company for the reason we don't have a good capital worth to support the loss for the two last years.
