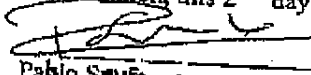

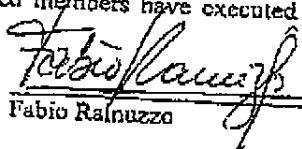

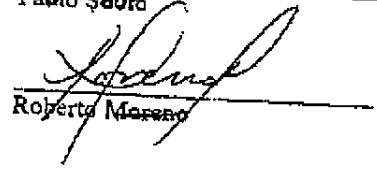
ARTICLE VI AMENDMENT

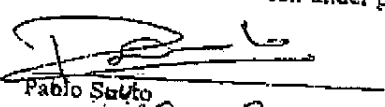

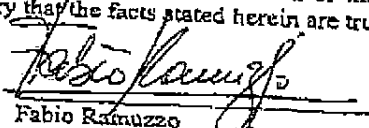

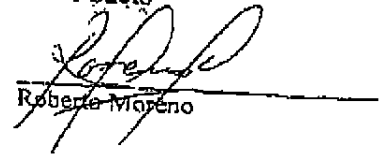
