ARTICLES OF ORGANIZATION

The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

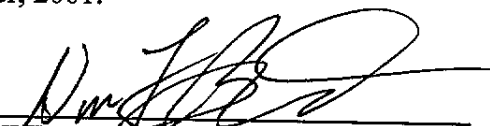
ARTICLE IV-Registered Office and Agent

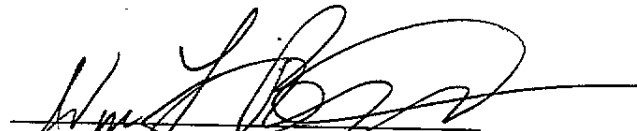
