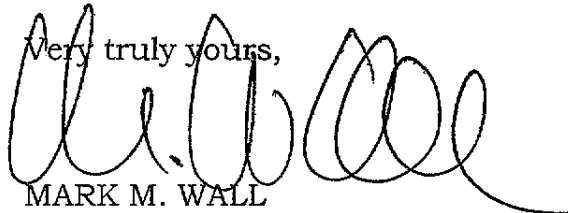

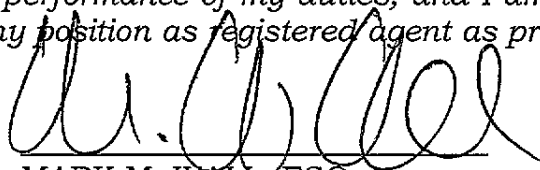

The business and affairs of the limited liability company shall be managed by and under the direction of a Board of Mangers.

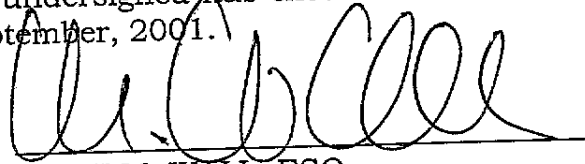
ARTICLE V
