

# ARTICLES OF ORGANIZATION FOR AVENTURA INVESTORS, L.L.C.

## ARTICLE I

### § 1.1 In General

Name. The name of the Limited Liability Company is Aventura Investors, L.L.C.

### § 1.2 Purpose

Purpose. The purpose of the limited liability company is to engage in any lawful act or activity for which a limited liability company may be organized under the Limited Liability Company Act of Florida.

(b) Certificate. The total authorized common capital certificate is: 500 shares of Class common.


