#### ARTICLE IX - MEMBERS' RIGHTS TO CONTINUE BUSINESS



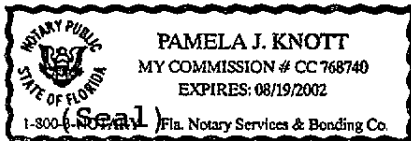
