## ARTICLES OF ORGANIZATION FOR PELLAJACK, LLC

ARTICLE 1 - Name. The name of the limited liability company shall be PELLAJACK, LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 907 Romano Avenue, Orlando, Florida 32807.

ARTICLE 3 – Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Philip K. Calandrino, P.A., 7232 Sand Lake Road, Suite 201, Orlando, Florida 32819.

ARTICLE 4 — Management. One manager shall manage the limited liability company. Therefore, it is a manager-managed company. The manager may elect to receive a salary for such services and may continue as manager until his resignation or removal for cause as determined by a majority vote of the members.

ARTICLE 5 – Membership. The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit, for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager.

ARTICLE 6 - Effective Date. The effective date of the limited liability company shall be October 5, 2001.

ARTICLE 7 – Purposes and Powers. The general purpose for which the limited liability company is organized shall be to engage in and transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida and all powers appurtenant thereto.
