ARTICLES OF ORGANIZATION  
OF

**Vishay II, LLC**

We, the undersigned subscribers of these Articles of Organization, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a limited liability company under Florida Statutes, Section 608.407, and other laws of the State of Florida; and to that end do hereby certify to the facts herein set forth as required by law.

**ARTICLE I**  
**NAME**




