NAME

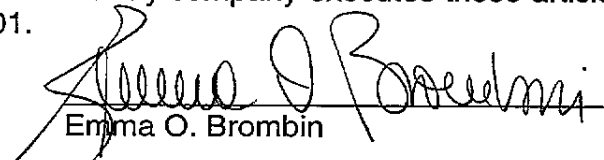

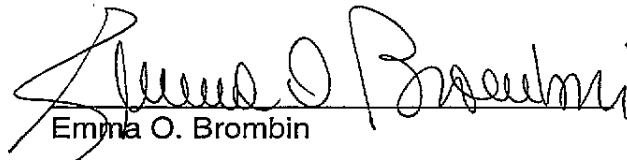
