**ARTICLES OF ORGANIZATION
FOR
SAS ENTERTAINMENT, LLC**

ARTICLE 1 - Name. The name of the limited liability company shall be SAS Entertainment, LLC.

ARTICLE 2 - Address of Principal Office. The mailing address and principal office of the limited liability company shall be 7040 Lake Ellenor Drive, Suite 118, Orlando, Florida 32809.

ARTICLE 3 - Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Allan Kardush, 7040 Lake Ellenor Drive, Suite 118, Orlando, Florida 32809.

ARTICLE 4 - Management. One manager shall manage the limited liability company. Therefore, it is a manager-managed company. The manager may elect to receive a salary for such services and may continue as manager until his resignation or removal for cause as determined by a majority vote of the members.

ARTICLE 5 - Membership. The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit, for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager.

ARTICLE 6 - Effective Date. The effective date of the limited liability company shall be October 5, 2001.

ARTICLE 7 - Purposes and Powers. The general purpose for which the limited liability company is organized shall be to engage in and transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida and all powers appurtenant thereto.


