ARTICLES OF ORGANIZATION
OF
STEVEN G. CALAMUSA, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be **STEVEN G. CALAMUSA, L.L.C.**

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the regulations.

ARTICLE VIII - MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the

ARTICLE XI - NO THIRD PARTY RIGHT(S)


The provisions of these Articles are for the exclusive benefit of the member and no other party (including without limitation any creditor of any member) shall have any right or claim against the company.

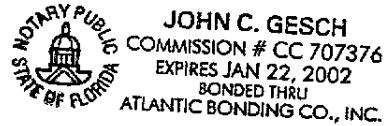
