**SECOND:** The following amendment to the Articles of Organization was adopted by the Limited Liability Company:


**RESOLVED:** That Article 1 - Name of the Limited Liability Company be amended to read as follows:

In all other respects, the Articles of Organization shall remain as they were prior to this Amendment being adopted.


