ARTICLE 1 – Name. The name of the limited liability company shall be PC Institute, LLC.

ARTICLE 2 – Address of Principal Office. The mailing address and principal office of the limited liability company shall be 5803 Chipola Circle, Orlando, Florida 32839.

ARTICLE 3 – Registered Office and Registered Agent. The name and the Florida street address of the initial registered agent is Robert G. Coleman, 5803 Chipola Circle, Orlando, Florida 32839.


ARTICLE 4 – Management. One or more managers shall manage the limited liability company. Therefore, it is a manager-managed company. The manager(s) shall receive a salary for such services and each may serve as manager until his or her resignation or removal for cause as determined by a majority vote of the members.

ARTICLE 5 – Membership. The company may issue certificates to indicate ownership in the company; with one percentage of ownership interest equating to one membership unit, for a total of 100 membership units. No change of membership in the company may occur without the unanimous consent of all then-existing members and the manager(s).

ARTICLE 6 – Effective Date. The effective date of the limited liability company shall be October 5, 2001.

ARTICLE 7 – Purposes and Powers. The general purpose for which the limited liability company is organized shall be to engage in and transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida and all powers appurtenant thereto.


