ARTICLES OF ORGANIZATION OF FIFTEEN BRICKELL REALTY, L.L.C.

ARTICLE I - Name:

The name of the Limited Liability Company is FIFTEEN BRICKELL REALTY, L.L.C. (the "Company").

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 1000 Brickell Avenue, Suite 910, Miami, Florida 33131.

ARTICLE III - Duration:
