


ARTICLE III

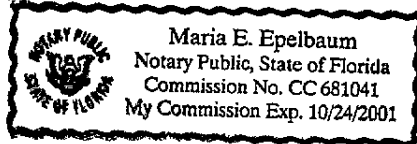


