**ARTICLES OF ORGANIZATION
OF
DAVID COLLINS REAL ESTATE CAREERS, LLC**

The undersigned, being the Member and Organizer of the Limited Liability Company hereby being formed under the Florida Statutes Annotated Sections 608.401 to 608.471, does hereby adopt the following Articles of Organization for the Limited Liability Company:

FIRST: The name of the Limited Liability Company is:

David Collins Real Estate Careers, LLC

SECOND: The latest date on which the Limited Liability Company is to dissolve is January 1, 2025.

THIRD: The Limited Liability Company is organized for the purpose of operating and conducting schools, seminars and courses designed to properly train individuals for careers within the real estate industry and to carry on any other activities necessary to, in connection with or incidental to the foregoing, or to conduct any other business activity not prohibited by the State of Florida or the United States, as the Members in their discretion may deem desirable.
