1. Name. The name of this limited liability company is CREEK ROCK INVESTORS, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence, with an Effective Date of October 8, 2001.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is c/o of Brett Sealy, Prager, McCarthy & Sealy, 200 S. Orange Avenue, Suite 1900, Orlando, Florida 32801.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of Membership. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. Management of the Company. The Company shall be managed by one or more of its managers in accordance with the operating agreement adopted by all of the members.
