PLAN OF COMPLETE LIQUIDATION AND DISSOLUTION OF GROUP HOMES, LLC

- 1. As soon as possible following the adoption of this Plan? of Complete Liquidation and Dissolution (the "Plan"), GROUP HOMES, LLC (hereinafter the "Company") will cease the active conduct of its business, will wind up its affairs, will pay or provide for payment of all known obligations of the Company, and will liquidate and distribute all of its assets in complete liquidation, less any assets retained to meet claims.
