ARTICLES OF ORGANIZATION FOR LIMITED LIABILITY COMPANY

These are the Articles of Organization of the Telco Software Consulting & Research, L.C., and are executed by the undersigned persons for the purpose of forming a Florida limited liability company under the Florida Limited Liability Company Act.

1. NAME

The name of the limited liability company is Telco Software Consulting & Research, L.C.

2. PURPOSES AND POWERS

To carry on a general investment and management consultant and advisory business relating to investments and the operation of business, plants, properties, and real and personal property of every kind, in the United States and foreign countries, subject to the applicable laws thereof. To

maintain executive and personnel for the purpose of consulting with and advising others in all matter relating to investments and the management and the operation of businesses and other properties of every kind. To furnish business investment and management plans and programs, to formulate policies, and generally to advise and assist others, under contract or otherwise, in the management of their businesses, plants, properties and investments. To buy and sell projects and developments on its own behalf and on the behalf of others in connection with the operation, management and development of individual and corporate businesses. To conduct research and to investigate businesses and enterprises of every kind and description throughout the world in order to secure information and data for capital investment, both for its own kind and description, whether as a promoter, partner, member or associate, or as a manager of other such enterprises.

To engage in consultant and advisory work in connection with the organization, financing, management, operation and reorganization of industrial and commercial enterprises.
