The right of the members to admit additional members and the terms and conditions of the admissions shall be provided in the Regulations of the Company.

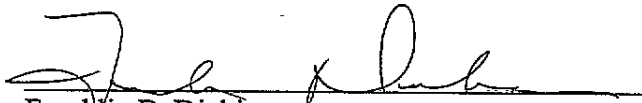
ARTICLE VI - Members' Rights to Continue Business

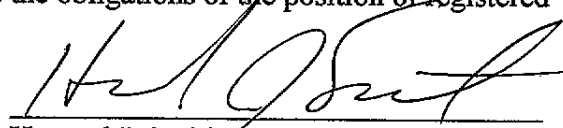
