ARTICLE I - Name

The name of this limited liability company shall be R & D LAWN SERVICE, LLC.

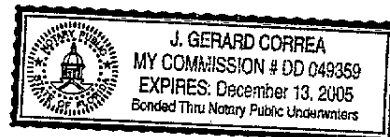
