**ARTICLES OF ORGANIZATION
OF

Continuation of Business



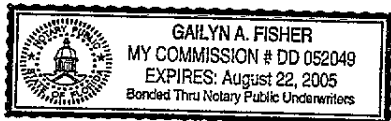
