
ARTICLE IV. MANAGEMENT



ARTICLE V. DURATION

This Limited Liability Company shall commence its existence on the date these Articles of Organization are filed with Florida Department of State. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in this Articles of Organization.

ARTICLE VI. PURPOSES AND POWERS

The general purpose for which this Limited Liability Company is organized is to operate the business of International Business Association, LLC, and to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida.

ARTICLE VII. CAPITAL CONTRIBUTIONS AND MEMBERSHIP

Each member of International Business Association, LLC shall contribute to the capital of the Company and shall become a member only upon such contribution is made in full. No additional member shall be admitted to the Company except with the written consent of all the members of the Company, and upon such terms and all members shall determine conditions. The existing members shall determine the amount and nature of the contributions proposed by new members at the time those new members are admitted.

ARTICLE VIII. CONTINUATION OF BUSINESS


The remaining members of International Business Association, LLC have right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Company.
