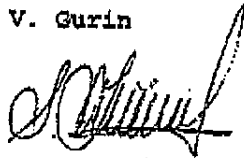

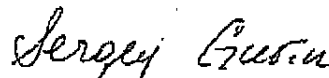

**ARTICLE V. DURATION**

This Limited Liability Company shall commence its existence on the date these Articles of Organization are filed with Florida Department of State. The company's existence shall be perpetual, unless the company is earlier dissolved as provided in this Articles of Organization.

**ARTICLE VI. PURPOSES AND POWERS**

The general purpose for which this Limited Liability Company is organized is to operate the business of IT Technologies, LLC, and to transact any lawful business for which a Limited Liability Company may be organized under the laws of the State of Florida.

**ARTICLE VII. CAPITAL CONTRIBUTIONS AND MEMBERSHIP**

All existing members shall determine the amount and nature of contributions proposed by new members at the time those new members are admitted.

ARTICLE VIII. CONTINUATION OF BUSINESS

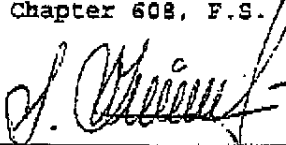
