



**ARTICLES OF ORGANIZATION OF
M. L. FERGUSON, LLC**

ARTICLE I

Name

The name of the limited liability company ("Company") is M. L. Ferguson, LLC.

ARTICLE VII

Effective Date

The effective date of the Company's organization is to be October 16, 2001.

ARTICLE VIII

Admission of New Members

The business may be continued only on the written consent of a majority of the remaining members.

Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the members listed in Article VI.
