ARTICLES OF ORGANIZATION

These Articles of Organization of BLACKFIN ASSOCIATES, LLC, a Florida limited liability company (the "Company"), dated as of the 22nd day of October, 2001, are being duly executed and filed by Harold W. Mullis, Jr., authorized agent, authorized to form a limited liability company under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) (the "Florida Act").

- FIRST:** The name of the limited liability company is BLACKFIN ASSOCIATES, LLC.
