The name of the Limited Liability Company is **COLONNADE MEDICAL PARK, LLC**.

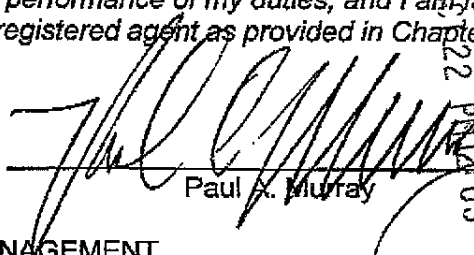

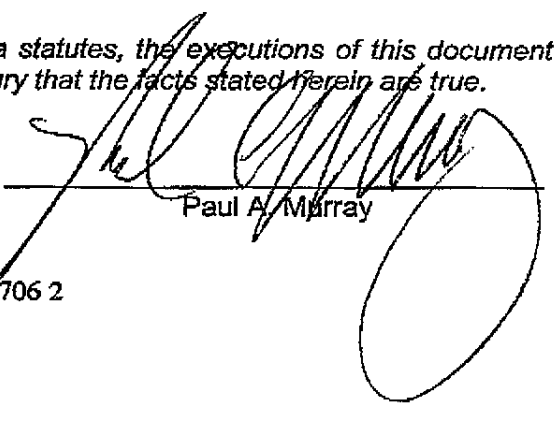
