

**ARTICLES OF ORGANIZATION  
OF  
ELITE LAWN CARE, L.L.C.**

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act found in Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I – NAME**

**Section 1.1** The name of the Limited Liability Company shall be **Elite Lawn Care, L.L.C.** (“Company”).

**ARTICLE II – ADDRESS**


## ARTICLE VI - MANAGEMENT



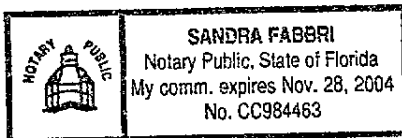

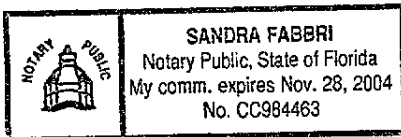
