**ARTICLES OF ORGANIZATION OF
CAMP AND FORE, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "CAMP AND FORE, LLC".

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 943 S.E. Fort King Street, Ocala, Florida 34471.

ARTICLE III - Duration:

The period of duration for the Company shall be perpetual.

ARTICLE VI - PURPOSE

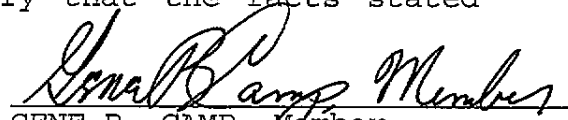
The Company is a single purpose limited liability company formed solely for the purpose of operating Burger King Restaurants.
