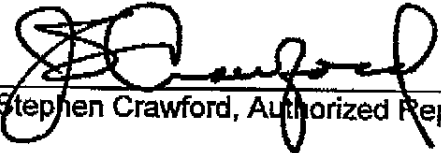
**ARTICLE VII
