REGULATIONS**



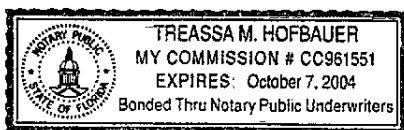
